2. License Grant

- The Licensee is authorized to use the Font Software to create end products, including printed materials, digital media, and merchendise. These end products must be in a form where the Font Software is embedded or incorporated, but not directly accessible or extractable by third parties.

4. License Limitations

- The number of Licensed Desktop Users permitted to use the Font Software may not exceed the amount specified in your account or transaction documents, such as on a quote or invoice.
- It is not allowed to embed, install, or use this Font Software as a web font, Mobile App, Server embedding, Original Equipment Manufacturer, or Video game.

5. Restrictions on Use
