2. License Grant

3. Scope of License

- You cannot use the font on websites (using @font-face), apps/eBooks, broadcasts, servers, or any other software embedding.
- Businesses or organizations, such as advertising or design agencies, that create multiple logos, wordmarks, device marks, or trademarks for their use or on behalf of clients must obtain a separate license for each distinct usage.

5. Restrictions on Use

You may not:

- Transfer your license rights to Font Software, except as expressly provided herein.
