

# Fitrah Type EULA

## Font Software For Broadcast End User License Agreement.

This End User License Agreement (the "Agreement") is a legal contract between you (the "Licensee") and Fitrah Type ("Licensor"), the copyright holder of the Fonts. For this Agreement, the term "Font Software" refers to the digital files that include the typeface design, encoding, and any associated code.

By downloading, accessing, or using the Fonts, you confirm that you have read, understood, and agree to be bound by the terms of this Agreement. If you disagree with the terms, you are not authorized to use the Fonts. This Agreement will become binding when you click the "ACCEPT LICENSE AGREEMENT" button or when you accept it through other means (such as a purchase order or confirmation email).

### 1. Binding Agreement

By accepting this Agreement, you acknowledge and agree that any use of the Font Software provided by Fitrah Type is subject to the terms and conditions set forth in this Agreement. You are legally bound by these terms for the entire duration of your use of the Font Software.

### 2. License Grant

Subject to the terms and conditions of this Agreement, Fitrah Type (the "Licensor") grants the Licensee a non-exclusive, non-transferable license to install, access, and use the Fonts. This license allows the Licensee to use the Fonts as specified in this Agreement but does not grant ownership or copyright to the underlying font designs. The Licensee acknowledges that they only purchase the rights to use the Fonts, and all intellectual property rights, including copyright, remain with the Licensor.

### 3. Scope of License

Subject to the terms and conditions of this Agreement, Fitrah Type grants the Licensee a non-exclusive, non-transferable license to use the Font Software for the following purposes:

**Broadcast License**

- You can install the Font Software on all production workstations necessary for pre-production and real-time rendering of the Font Software for broadcasting/TV/cinema titling.
- Allows the use of Font Software in on-screen broadcasts, including online video ads, streaming, television, and movies. It applies to dynamic text such as titles and credits and is valid indefinitely for one title across all platforms.
- The Licensee is authorized to use the Font Software to create end products, including printed materials, digital media, and merchandise. These end products must be in a form where the Font Software is embedded or incorporated, but not directly accessible or extractable by third parties.

**4. License Limitations**

- It is not allowed to embed, install, or use this Font Software as a web font, Mobile App, Server embedding, Original Equipment Manufacturer, or Video game.
- Businesses or organizations, such as advertising or design agencies, responsible for managing multiple broadcast, TV, or video streaming projects must obtain separate licenses for each project or title.

**5. Restrictions on Use**

You may not:

- Transfer your license rights to Font Software, except as expressly provided herein. You may transfer all your rights to use the Font Software to another person or legal entity provided that (i) the transferee accepts and agrees to be bound by all the terms and conditions of the Agreement, (ii) you destroy all copies of the Font Software, including all copies stored in the memory of a hardware device and (iii) there is no change to the intent or scope of the rights granted by this Agreement as a result of such transfer.
- Rent, lease, sublicense, lend, or distribute the Font Software or any copies of it, except as expressly authorized in this Agreement.
- Modify, alter, or create Derivative Works from the Font Software, in whole or in part, unless explicitly permitted in this Agreement. If the Font Software contains embedding bits that indicate that the Font Software is only authorized for certain purposes, you may not change or alter the embedding bits.

- Embed the Font Software in open-source software that could result in the Font Software becoming publicly available or subject to the terms of a publicly available software agreement.

## **6. Intellectual and Industrial Property Rights**

You agree that Font Software is protected by copyright law, intellectual and industrial property rights, and international treaties. The Font Software, its structure, code, and related files are valuable property of Fitrah type, and any intentional or negligent Use of the Font Software not expressly permitted by the Agreement constitutes an infringement of intellectual and industrial property rights.

## **7. License Updates**

Fitrah Type (the "Licensor") reserves the right to update or modify the terms of this Agreement, including the scope of the license, at any time. Any updates or modifications will be communicated to the Licensee in writing or electronically. However, these changes do not automatically amend the license agreement the Licensee has previously purchased.
